Dear Mr. Anthony:

You have informed me that Mr. Alton has withdrawn the subpoena where he was requesting data in reference to medical legal evaluations. Data that has already been released based on earlier subpoenas includes the number of attorney referral evaluations I have performed over the past few years. More specifically, from 1/1/97 through 3/31/99 I performed 609 medical legal evaluations at the request of attorneys. That would include personal injury as well as Workers' Compensation evaluations. Charges for those 609 medical legal evaluations totaled \$367,785. In reference to depositions, from 1/1/97 through 3/31/99 I was involved with 168 depositions with charges totaling \$139,830.
